

## **Privacy Policy**

We respect your privacy and give special attention to the confidentiality of information submitted to us.

### **1. General provisions.**

- 1.1. This document «Privacy Policy» (hereinafter – the Policy) contains rules of using by FASTPANEL by P.A.G.M. OU (hereinafter – FASTVPS) the information collected about User.
- 1.2. Visiting our Site and downloading, installing and using the FASTVPS's software (hereinafter - Products), you accept all terms and conditions of this Policy.
- 1.3. This Policy is a part of documents that refer hereto, including License agreement that set forth terms and conditions of use of the Products.
- 1.4. Unless otherwise is provided for by this Policy, all terms and definitions used herein shall have the meaning defined in the License agreement.

### **2. Personal Information**

- 2.1. Personal information for the purposes of this Policy shall mean information that can be associated with a specific User, such as: name, address, telephone number, e-mail address, and information about User's use of the Products and purchases made.
- 2.2. FASTVPS processes Personal information that User provides about himself by filling out respective forms.

When downloading free version of the Products, subscribing to email newsletters, contacting FASTVPS for technical support or via feedback form User provides his name and email.

When ordering fee-base License User is required to provide the following information: name, address, phone number.

When you use the Products the following information may be transmitted automatically to FASTVPS: IP-address, information about browser, statistic information about use of the Products (number of websites, number of databases, etc.).

FASTVPS may set out the requirements to the information that should be necessarily submitted in course of certain User's actions. If some information is not marked by FASTVPS as mandatorily required, then User submits or discloses such information at his own discretion.

- 2.3. If the information submitted by you contains personal data, you freely and voluntarily grant FASTVPS written permission to process that data for the purposes set forth by this Policy. This includes such actions (operations) or sequence of actions (operations) performed with or without using automated tools as: collecting, sorting, accumulating, storing, specifying (updating, changing), withdrawing, using, transferring (providing, accessing) information to the third parties, including cross-border transfer to other jurisdictions, anonymization, blocking, deleting, and destruction of personal data.

### **3. Credit Card Purchases.**

- 3.1. If you use a credit card to purchase a FASTVPS Product, the credit card number is encrypted as it passes over the internet. Information about your credit card is not kept in or recorded by FASTVPS's computers, it is simply passed through to the credit card company. In this respect, credit card purchase in the Internet is similar to a credit card purchase at any store.
- 3.2. Such information about User as name, address and purchased Product is kept by FASTVPS for further delivery of the Product and service.

### **4. Use of Personal Information.**

- 4.1. FASTVPS uses Personal information for the following purposes:

- 4.1.1. Execution and performance of License agreements with User;
- 4.1.2. Identification of User in the course of fulfilling FASTVPS's obligations under the agreements with User;
- 4.1.3. Communication with User for the purposes of informational support and improvement of the Products, including notification through the third parties;
- 4.2. FASTVPS may share Personal information with service providers that provide services on our behalf when it is necessary for provision of such services within the limits of the purposes listed above.

## **5. User's consent to receiving information from FASTVPS**

- 5.1. Submitting your email address when completing forms on the Site or downloading the Products, you agree to receive emails from FASTVPS containing information about updates and any other information related to the Products, as well as other types of information from FASTVPS, including advertisements. You can unsubscribe from this service at any time. To do so, follow the instructions on the link in the letter or email us at the address [SUPPORT@FASTPANEL.DIRECT](mailto:SUPPORT@FASTPANEL.DIRECT) with a request to delete your data from the mailing list.

## **6. Confidentiality of User Information**

- 6.1. FASTVPS stores information of Users and takes necessary and sufficient organizational and technical security measures of protection from unauthorized access and disclosure in compliance with internal rules and procedures.
- 6.2. Information of Users is kept confidential with the exception when technology or settings of the Products allow open exchange of information with other Internet or Products users.

## **7. Third parties**

- 7.1. To implement purchases in Products FASTVPS uses services of third parties – well-known payment services that guarantee the security of financial operations.
- 7.2. Site and Products may contain links to websites of the third parties. When User follows these links he leaves the Site/Products, and FASTVPS takes no responsibility for the safety of User data during the use of third parties websites. Such websites may have their own privacy policy setting out the rules of collection and storage of User data. This Policy does not cover the data which is submitted to, stored or used by third parties websites. You are recommended to carefully review the privacy policy of such third party when entering its website.
- 7.3. FASTVPS is not responsible for the use of User information by the third parties that User interacts with in course of using the Products.

## **8. Other disclosures of Personal Information:**

- 8.1. FASTVPS may disclose Personal information to the third parties in the following cases:
  - 8.1.1. User expressed his consent to such disclosure including cases when User applied software settings which disable restriction of disclosure of particular data;
  - 8.1.2. Disclosure is required in course of using certain functions of the Products;
  - 8.1.3. Transfer of all or some of FASTVPS's assets to possession, use or ownership of third party including assignment of rights under the executed agreements with User to such third party.
  - 8.1.4. At the request of a court or other authorized governmental agency to the extent required under applicable legislation.
  - 8.1.5. For the purpose of protection of FASTVPS's rights with respect to the breach of agreements executed with User.

## **9. Amendments**

- 9.1. This Policy may be amended or cancelled by FASTVPS at its own discretion without prior notification of User. We recommend that you regularly read the latest version of the privacy policy.
- 9.2. New version of the Policy is effective from the moment of its placement unless otherwise is provided for by such new version of the Policy.
